Dear Alumni and Friends:

Thanks to your generosity, the law school enjoyed its best year ever in terms of dollars raised and its third-best year ever in number of alumni donors and alumni participation rate. Given the stressful economic times, this is a remarkable performance. We are very grateful.

For the first time, new gifts and pledges to George Mason Law's general fund and general scholarship fund totaled over \$1 million (up 19.0 percent from FY10). Including dollars raised and gifts pledged for faculty, research, and other purposes, total financial contributions totaled \$6.5 million (more than double FY10).


Alumni participation, the backbone of annual support, tallied another good year. Over 960 alumni donors made gifts to Mason in FY11, producing an alumni participation rate of 15.8 percent. For the fifth consecutive year, the law school had the highest alumni participation rate (by far) of any academic unit at George Mason University.

These results speak volumes regarding the alumni and friends who support the School of Law. Gifts to George Mason Law are investments in the value of your degree and the vitality of the law alumni as a body. Your gifts help us attract and retain the best possible student body, provide them with a legal education that is both practical and deep, help prepare them for life after graduation, and provide a continuing resource for their professional growth.

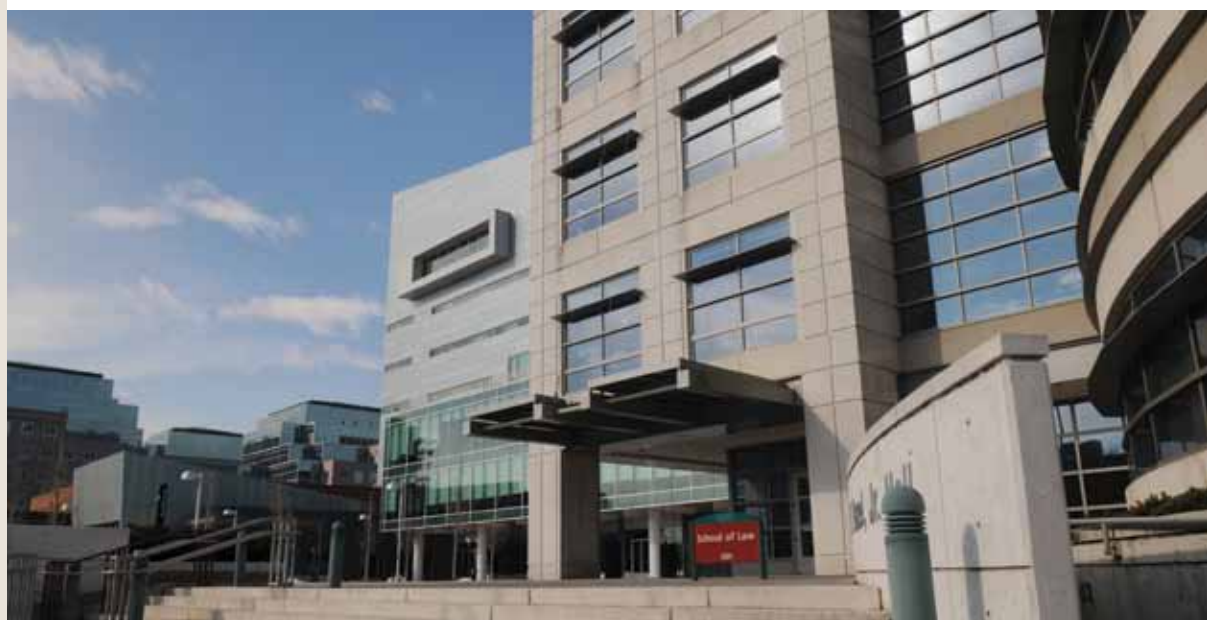
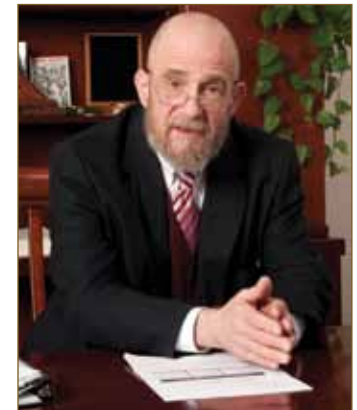
