(N.1) This course will meet for the first ten weeks of the fourteen week semester. The class meeting time has been extended accordingly. The exam will be administered shortly after the course ends on the date and time listed on the course schedule.

(N.2) Information regarding the application process will be sent via LawNews email. The class meets for two hours a week but students receive three credits total given other assigned work and meetings outside of the regularly schedule classroom time.

(N.3) This course will meet in the United States Bankruptcy Courthouse (200 South Washington Street) in Alexandria, VA on the 2nd and 4th Friday of each month, between 10:00 am and 1:00 pm, beginning in late August and continuing into early December.

(N.4) Students who completed Law 164 previously are not eligible to repeat the course (even if the course is titled differently) because of the overlap in subject matter.

(N.5) This course is scheduled from 4:00 - 5:50 pm but, on occasion, will meet from 4:00 - 5:15 pm (on dates to be listed on the course syllabus).

(N.6) Patent Law I & II will not be offered during the day in Academic Year 2017-2018. A 4 credit Patent Law course will be offered during the day in Spring 2018 instead (covering Patent Law I & II in one course). Students may choose to take either Patent Law I (Fall 2017) and Patent Law II (Spring 2018) in the evening, or Patent Law as a 4 cr course during the day in Spring 2018.

(N.7) This course will not meet weekly but will meet on assigned dates over the course of the semester as determined by the instructor.

(N.8) Applications will be accepted via Symplicity. Application information will be sent out via LawNews email. Additional information about the externship programs is available on the CAS website..
