(N.1) The Arts & Entertainment Clinic meets for two hours a week but students receive three credits total because of meetings and work required outside of the regularly scheduled classroom time. Information regarding the application process has been sent via LawNews email.

(N.2) The Bankruptcy Externship program will meet in the United States Bankruptcy Courthouse (200 South Washington Street) in Alexandria, VA on the 2nd and 4th Friday of each month, between 10:00 am and 1:00 pm, beginning in late August and continuing into early December.

(N.3) The Federal Circuit Practice Seminar has been designated as a prerequisite for the Giles Rich Moot Court Competition (Law 125) scheduled for Spring 2020.

(N.4) The Immigration Litigation Clinic meets for two hours a week but students will receive four credits total because of meetings and work required outside of the regularly scheduled classroom time. Information regarding the application process has been sent via LawNews email.

(N.5) International Criminal Law is a one-credit course that will meet for two hours on Friday each of the first eight weeks of the semester, except there is no class on Sept. 27.

(N.6) The Law & Economics Colloquium is scheduled from 4:00 - 6:00 pm but, on occasion, will meet from 4:00 - 5:25 pm (on dates to be listed on the course syllabus). JD students who have taken the course once may enroll in the course a second time because course content changes semester to semester.

(N.7) The Practicum meets for two hours a week but students receive three credits total because of meetings and work required outside of the regularly scheduled classroom time. Information regarding the application process for the Practicum has been sent via LawNews email.

(N.8) The MVETS Clinic meets for two hours a week but students receive four credits total because of meetings and work required outside of the regularly scheduled classroom time. Information regarding the application process will be sent via LawNews email.

(N.9) The Mental Illness Law Clinic meets for two hours a week but students receive three credits total because of work performed outside of the regularly scheduled classroom time, including attending civil commitment hearings at local hospitals. See Clinic Information Packet and course syllabus for more detail.

(N.10) The Negotiations class will be offered over two weekends, Sept. 27-29 and Nov. 1-3, meeting each weekend on Fridays (1:30-6:00P), Saturdays (8:00A-6:00P), and Sundays (8:00A-3:15P). Students must attend every session to receive credit for the course.

(N.11) Patent Law I & II will not be offered during the day in Academic Year 2019-2020. A four credit Patent Law course will be offered during the day in Spring 2020 instead (covering Patent Law I & II in one course). Students may choose to take either Patent Law I (Fall 2019) and Patent Law II (Spring 2020) in the evening, or Patent Law as a four credit course during the day in Spring 2020.

(N.12) Readings in Legal Thought will not meet weekly but will meet on assigned dates over the course of the semester as determined by the instructor.

(N.13) Students must receive approval to be registered in any Supervised Externship and should submit the Externship Information Form found in the Externship module on Symplicity to begin the process. (Virginia Practice Externship applicants will submit the form after meeting with Professor Davis and Ilissa Belanger.) To access the form, log into Symplicity and select Externship module from the "Shortcuts" on the right side of the screen. Once approved, students will be registered by the Records Office for the appropriate externship course. Students NOT being compensated for the work performed during their externship will be registered for Law 320, 321, or 179. Students being compensated for the work performed during their externship will be registered for Law 520, 521, or 579. Students are limited to a maximum of 6 credits hours of compensated externship and such credit may be earned only in a student's final two full semesters (fall or spring).
