NOTES CONTINUED:

**(N.1)** Students who have taken this course once may enroll in the course a second time because the assigned readings change semester to semester.

**(N.2)** This course will meet for 2 hours at a time, although it is a 3 credit course. It will meet 21 times over the course of the semester instead of 28 times. Class dates to be announced in the syllabus.

**(N.3)** Information regarding the application process has been sent via LawNews email. The class meets for two hours a week but students receive three credits total given other assigned work and meetings outside of the regularly scheduled classroom time.

**(N.4)** This course will meet offsite two Fridays a month at the U.S. Bankruptcy Court in Alexandria, Virginia, between 10:00 a.m. and 1:00 p.m. The first meeting date will be announced by the instructor.

**(N.5)** Enrollment will be by application and written permission of the instructor. Prerequisites are Administrative Law and Constitutional Law I. To apply, **on or before Monday, November 26**, please email Professor Mascott ([jmascott@gmu.edu](mailto:jmascott@gmu.edu)) your resume; transcript; and one paragraph statement of interest in the class. Students should consider registering for an alternative course while applications are reviewed. **All applicants who are chosen will be notified by Wednesday, November 28**, and will be contacted by the Records Office.

(N.6) Students ranked in the bottom quartile (25%) of the class at the start of their final year are required to take this course pursuant to AR 3-3.2(d). Students required to take the course will be notified via email in advance of registration. The course will also be open to additional students who are in their final semester on a first come, first served basis, at a date to be announced via LawNews email.

(N.7) This course meets for two hours but students earn three credits because of Clinic work performed outside the regularly scheduled class time.

(N.8) This course will not meet every week, but will instead meet 3-4 times over the semester. Students who took this course in Fall 2018 are eligible to register for the course in Spring 2019 because the assigned readings are different each semester.

(N.9) To seek approval to register for the general Supervised Externship program or the Capitol Hill Externship program, please complete and submit the Externship Information Form found in the new Externship module on Symplicity. (For the Spring 2019 semester, Virginia Practice Externship applicants will submit the form after meeting with Professor Davis and Ilissa Belanger.) The form should be submitted for approval even if supervisor information is unknown. Supervisor information may be entered at a future date. Once approved, students will be registered by the Records Office into the appropriate externship course. Log into Symplicity and select the Externship module from **the Shortcuts** on the bottom right of your screen. Select "add new" and proceed to fill out the information form.

All approved externship students should attach to the Externship Information Form a signed Service Agreement found in the externship information packets (<https://www.law.gmu.edu/academics/clinics/>) no later than the second week of the semester, unless permission was given to submit the document at a later date.

**Students NOT being compensated for the work being performed during their externship will be registered for Law 179, 320, 321, or 325. Students being compensated for the work being performed during their externship will be registered for Law 520, 521, 525, or 579.** Students are limited to a maximum of 6 credit hours of compensated externship credit and such credit may be earned only in a student's final two full semesters (fall or spring).
