

## SPRING 2019 REGISTRATION FOR FIRST YEAR STUDENTS

First year students will use PatriotWeb (<https://patriotweb.gmu.edu>) to register for their spring course selections beginning on November 27, 2018, at 9:00 am. Although first year students follow a pre-set schedule, the process of registering will allow students to become familiar with how to use the PatriotWeb registration system.

In addition, the law school offers a Winter Term in conjunction with the Spring 2019 semester. Courses selected in the Winter Term are considered part of the Spring Semester. Some Winter Term courses are open to 1D students; 1E students may enroll in Winter Term courses in their 2E through 4E years.
