

Spring 2020 Registration Information for First Year JD Students

First year JD students will use PatriotWeb (<https://patriotweb.gmu.edu>) to register for their spring courses beginning on November 25, 2019, at 9:00 a.m. Although first year students follow a pre-set schedule, the process of registering will allow students to become familiar with how to use the PatriotWeb registration system.

In addition, the law school offers a Winter Term in conjunction with the Spring 2020 semester. Winter Term courses are considered part of the Spring Semester. All first year students are required to take the LRWA II programming during Winter Term. Other Winter Term courses are open to 1D students if they do not conflict with LRWA II; 1E students may enroll in Winter Term courses in their 2E through 4E years. Prior to November 25, please log in to PatriotWeb to confirm your individual registration time ticket and **check for any holds that could prevent you from registering**.
