(N.9) Students must receive approval to register for the Supervised Externship programs and should submit the Externship Information form found in the Externship Module on Symplicity to begin the process. (Virginia Practice Externship applicants will submit the form after meeting with the program directors.) To access the form, log on to Symplicity and select the Externship Module from the "Shortcuts" on the right side of the screen or the "Experiential Module" (it shows both ways) and select "add." Once approved, students will be registered by the Records Office for the appropriate externship course. Students not being compensated for the work performed will be registered for Law 320, 321, or 179. Students being compensated for the work being performed will be registered for Law 520, 521, or 579. Students are limited to a maximum of 6 credit hours of compensated externship credit and such credit may be earned only in a student's final two full semesters (fall or spring).

(N.10) This course is offered online through the law school's online partner, iLaw, asynchronously, with no assigned meeting times, although there will be weekly obligations and assignments over the course of the spring semester. More information will be available in the syllabus.
