## **COURSE DESCRIPTION**

Startup Company Law is a business law class that will follow the lifecycle of the startup company. This class will examine core legal and business issues facing startup companies, including in relation to formation, fundraising, scaling, operations, and exit. The Startup Company Law class will also work tasks associated with establishing the Spring 2025 Startup Company Clinic as a startup endeavor.
