### Spring 2024 Registration Information for First Year JD Students

First year JD students will use PatriotWeb (<a href="https://patriotweb.gmu.edu">https://patriotweb.gmu.edu</a>) to register for their spring courses beginning on Wednesday, November 8<sup>th</sup> at 9am. Although first year students follow a pre-set schedule, students register themselves for spring courses to become familiar with the PatriotWeb registration system.

In addition, the law school offers a Winter Term in conjunction with the Spring 2024 semester. Winter Term courses are considered part of the Spring Semester (so Winter Term credits count towards Spring 2024 credit totals). ## **LRWA-II Trial Level Writing**

First year JD students must register for LRWA II (Law 097) in the same section (001, 002, or 003) as their Fall 2023 LRWA I (Law 096) registration.

- For example, if you are registered for LRWA I (Law 096) Section 001 with Professor FitzGerald this fall, you must register for LRWA II (Law 097) Section 001 with Professor FitzGerald in the spring.
- Students can identify their Fall 2023 section number by checking their Fall 2023 registration in PatriotWeb or by consulting the Fall 2023 Course Schedule on the law school website.
