#### Course Overview

The course will emphasize aspects of patent prosecution including law, rules, pleadings and forms, strategy, trends, and client counseling. This course is intended to be very practical. We will discuss real examples and strategies in an interactive way. Assignments are tailored to questions and analysis likely to be asked of a practicing patent attorney.

### Course Learning Outcomes

- 1) Understand the overall patent prosecution/examination process in the US and foreign countries.
- 2) Understand how to respond to office actions (e.g., restriction requirement, obviousness type double patenting rejections, and/or rejections under 35 U.S.C. §§ 101, 102, 103, and/or 112)
- 3) Understand formalities (e.g., assignment, declaration, power of attorney, etc.) at the patent office.
- 4) Understand the interplay between inter partes proceedings (IPR, PGR, litigation, European opposition, etc.) or ex parte proceedings (third party submission, ex parte reexamination, supplemental examination) and prosecution.

# **Grading Policies**

- 1) Two in-semester assignments (60%)
- 2) Final semester presentation (40%)
- 3) There is no final exam. Grading will be based on the two written assignments and one presentation. Late submission of assignments will result in a reduced grade unless a petition for extension of time is approved in advance.
- 4) Grades will be adjusted to account for exceptional class participation in accordance with GMU policy.
- 5) Guest lecturers may also be invited for selected topics.

#### Classroom Policies

Additional instruction and guidance will be provided at the end of each class for the preparation and reading required for the next class meeting.
