**COURSE OVERVIEW/DESCRIPTION:** This course will focus on the skills and theories involved in the mediation process. Students will develop these skills through active participation in simulated exercises, role-plays, and interactive lectures. Discussions of the theoretical and practical basis for meditation, as well as ethical issues inherent in this practice will play a critical role in this course. Further, special attention will be given to the role of attorneys in mediation.

## **LEARNING OUTCOMES:**

By the end of the course students should have:

- Learned the theoretical basis and legal framework of mediation and recognize when the use of mediation is appropriate.
- Learned to effectively mediate and co-mediate a variety of disputes.
- Learned additional communication skills and enhanced existing skills.
- Learned the relationship of mediation to the court system and the role of attorneys as advocates for clients during the mediation process.

## **BASIS OF EVALUATION & ASSESSMENTS:**

- Due to the experiential nature of the class, including frequent participation in role plays (see Course Policies, below), class participation and application of skills comprises 30% of the grade.
- A conflict journal that will entail a weekly entry that is relevant to topics discussed during the previous class. The entry may be in the form of an insight gained regarding a specific issue, or an experience either observed or read. Two entries will be submitted during the semester, each with a minimum of one page and maximum of two pages (15% of the grade.)
- A take-home final exam distributed at the conclusion of final class of the semester, and due, by email, at 12:00 noon, on May 5, 2025 (55% of the grade.)

**COURSE POLICIES:** A significant part of each class will be devoted to role play simulations and other interactive activities. Class attendance, therefore, is *required*. (See Attendance, below.) Absence or lateness will have a significant negative effect on your grade (excused absences are limited to religious observances, or medical or family emergencies). If you expect to miss a class, you must provide notification to the instructor prior to the class you will miss. Before each role play, you may receive some "confidential information." Please do not discuss the "confidential information" with your classmates, except during the simulation with your assigned counterpart(s). Students are also expected to do the readings assigned for each class.
