

## SPRING 2026 REGISTRATION INFORMATION FOR FULL-TIME FIRST YEAR JD STUDENTS

As a first-year JD student, your [Spring 2026](#) course schedule is pre-set and will include these five required courses: **Civil Procedure**, **Legislation and Statutory Interpretation**, **Criminal Law**, **Contracts II**, and **LRWA II**.

While your schedule is pre-set, **you are required to register for these courses yourself** using [PatriotWeb](#). This process ensures you become familiar with the university's online registration system—a critical skill for your future semesters.

The registration window opens on **Wednesday, November 5th at 9:00 AM EST**.

Before that day arrives, you have two essential steps to take:

1. [Log in to PatriotWeb now](#) to confirm your individual registration time ticket.
2. **Check for any holds.** If there are any financial, administrative, or other holds on your account, they will prevent you from registering. Resolving them now to prevent registration delays.

### Civil Procedure & Legislation & Statutory Interpretation

Your Spring 2026 registration for **Civil Procedure (Law 112)** and **Legislation & Statutory Interpretation (Law 266)** must correspond to your assigned section. Your assigned section corresponds to your Torts and Property sections. For example, if you have Meyers for Torts and Alvare for Property, you are in Section 001.

### Contracts II & Crim Law

Register for **Contracts II (Law 103)** and **Criminal Law (106)** based on the same section as your Fall 2025 Contracts I (Law 102) section. Therefore, if you have Lu for Contracts I, you must register for Contracts II Law 103-001 and Criminal Law 106-001. If you have Schooner for Contracts I, you must register for Contracts II Law 103-002 and Criminal Law 106-002.
